### PARENT GOVERNOR ELECTION NOMINATIONS & VOTING LETTER

Once you have marked the ballot paper you should seal it in the envelope. This should then be put in the ballot box, which can be found in the school hall on Wednesday 14<sup>th</sup> December from 8:00 a.m. to 9:30 a.m.

Unfortunately, as there are postal strikes at present we are unable to offer the option of postal votes.

The count will take place at 9:30 a.m. on **Wednesday 14<sup>th</sup> December** in the school hall. The election will be decided by a simple majority of votes cast. In the event of a tie, lots will be drawn. All candidates are welcome to attend the count.

When the election has been completed, I will let you know the outcome. If, in the meantime, you have any queries, please let me know.
